Investigatory Stops, Protective Pat Downs, and Enforcement of Loitering Ordinances: ¶834

834. CPD will continue to post de-identified investigatory stop data derived from ISRs or Stop Reports on its website (currently, <https://home.chicagopolice.org/statistics-data/isr-data/>) on an annual basis, including fields for which information is collected on the ISR or Stop Report. CPD also will continue to post on its website the ISR data dictionary or an equivalent data dictionary for Stop Report data.

In the twelfth reporting period, the City and the CPD achieved Full compliance with ¶834.

To assess Preliminary compliance with ¶834, the IMT reviewed the de-identified investigatory stop data that was submitted by the CPD and that was posted by the CPD to its website.

To assess Secondary compliance with ¶834, the IMT reviewed evidence of the sustainability of the CPD's posting of de-identified investigatory stop data and pre-implementation drafts of S10-02—the *Gang and Narcotics Related Loitering* policy suite—and G03-08—the *Police Encounters and the Fourth Amendment* policy suite. Specifically, as requested by the IMT, G03-08-03 Section VIII.C.3.b identifies the specific entity responsible for posting the CPD's de-identified data as the Information Services, Office of Public Safety Administration (also known as OPSA).

To assess Full compliance, the IMT considered evidence of the CPD's consistent posting of de-identified investigatory stop data.

During this reporting period, the City and the CPD produced their de-identified Investigative Stop Report (ISR) data to the IMT and the Office of the Illinois Attorney General through April 2025 for review. The CPD has now collected, maintained, and posted on its website. This documentation supports Full compliance with ¶834.

To maintain Full compliance, the City and the CPD must continue to collect, maintain, and post on its website its investigatory stop data. The CPD must also continue to update related policies and the ISR data dictionary posted on its website

as changes are made to forms. Additionally, the CPD must elicit community feedback on public ISR data as part of other community engagement efforts.

Investigatory Stops, Protective Pat Downs, and Enforcement of Loitering Ordinances: ¶858

858. For the representative sample of ISRs and Stop Reports described in Paragraph 857 of this Stipulation, CPD must demonstrate that the subset of investigatory stops and protective pat-downs reviewed is demographically and geographically representative of community members stopped by CPD officers throughout Chicago.

In the twelfth reporting period, the City and the CPD achieved Secondary compliance with ¶858.

To assess Preliminary compliance with ¶858, the IMT reviewed the *Tactical Review and Evaluation Division (TRED) 2023 Year End Report*, which demonstrated that the City and the CPD were creating the representative sample of Investigative Stop Reports (ISRs) and Stop Reports and demonstrating the breakdown of data by demography and geography.

To assess Secondary compliance with ¶858, the IMT requested an outline of CPD’s process for evaluating whether the sample of ISRs and Stop Reports are indeed representative.

To assess Full compliance, the IMT considered evidence from the CPD that demonstrates the identified representative sample is in fact geographically and demographically representative, as well as progress by the City and the CPD in clearing the backlog of ISRs awaiting review by the CPD’s Fourth Amendment Stop Review Unit (4ASRU).

This reporting period, the CPD reported monthly to the IMT and the OAG on its assessment of whether the sample of ISRs and Stop Reports are representative, including a description for its process for evaluating whether the sample is representative. These discussions have provided some clarity on the CPD’s analysis and process for evaluating the level of representation of community members stopped by CPD officers throughout Chicago. Additionally, the CPD produced their representative sample ISR data for the IMT and the OAG through April 2025 for review. This documentation supports Secondary compliance with ¶858.

To achieve Full compliance, the CPD will need to continue to demonstrate that its ISR and Stop Reports data is demographically and geographically representative. As we’ve previously discussed with the CPD, the IMT requests that the CPD provide

aggregated representative sample data for the year-to-date at monthly meetings moving forward.

Additionally, the IMT will assess the CPD’s progress toward clearing the backlog of ISRs awaiting review from the 4ASRU when evaluating the CPD’s Full compliance with ¶858.

We look forward to continuing to assess whether the representative sample is demographically and geographically representative. The CPD should continue to include an analysis of the representative sample in annual CPD reports, including TRED reports, and provide year-to-date data to the IMT monthly. Additionally, the CPD should solicit community feedback on the representative sample throughout ongoing community engagement efforts.
