



# **Health Equity Work**

North River Commission is a community lead for the Northwest Regional Healthy Chicago Equity Zones (HCEZ). In partnership with Northwest Center and the Chicago Department of Public Health we aim to identify and improve the social determinants of health.

In 2022, North River Commission conducted community outreach, identified public safety and housing as main social determinants of health, and is continuously advocating for initiatives to address them.

Albany Park is one of the most diverse communities in America. The neighborhood is a quintessential melting pot, with a dynamic array of businesses representing Mexican, South American, Filipino, Korean, Indian, Cambodian, Somali, Romanian, and Middle Eastern cultures.







# The City's achievements through IMR-7

- Achieved at least Preliminary compliance with 83% of monitorable paragraphs through the seventh reporting period
- The CPD provided comprehensive training to its School Resource
   Officers
- •The City and the CPD developed the Search Warrant Community Resource and Referrals Pilot Program

# The City's ongoing challenges

- CPD staffing, which affects nearly all aspects of Consent Decree compliance, including community policing, crisis intervention, supervision, and TRED
- CPD's Community Engagement and Trust Building, along with coordinating its CAPS,
   NPI, and other initiatives
- High-quality, timely training based on an annual Needs Assessment and Training Plan
- Internal reviews, i.e., Tactical Review and Evaluation Division, which has a backlog of force cases to review
- CPD still has not implemented an officer suicide prevention initiative
- No progress on analyzing citywide and district-level data on use of force
